JOB SPECIFICS: The teacher shall serve as the education leader. This position is a long-term substitute position and will be for the remainder of the 2024-2025 school year, from approximately January 13, 2025 - June 6, 2025.

DISTRICT DESCRIPTION: Elk Rapids Schools has approximately 973 students in grades K-12 and is located in the northwest lower peninsula. Elk Rapids Schools also serves as an authorizer of Mill Creek Academy, a K-5th grade District that educates approximately 230 students. This position would provide Physical and Health Education for K-5 students in both Districts.

- Communicate necessary information regularly to students, colleagues, and parents regarding student progress and student needs..
- Organize and maintain inventory of school-owned equipment and instructional materials.
